



# 2008 CALL FOR NOMINATION TO THE ICC BOARD OF DIRECTORS

In accordance with the Bylaws of the International Code Council, elections for officers and to fill vacant positions on the Board of Directors shall be held at the Annual Business Meeting in September 2008. All candidates for the Board of Directors who have not previously served on the Board of Directors shall submit to the Chair of the Nominating Committee a letter of interest, current resume and any other information they feel necessary to support their candidacy. Candidates will be individually interviewed by the Nominating Committee at a time and place to be announced in conjunction with the Annual Business Meeting. An incumbent on the ICC Board of Directors shall submit a letter to the Chair of the Nominating Committee declaring interest in a nomination. To assure an interview appointment, letters of interest must be received by August 1, 2008.
